Sac Food Bank and Family Services is now the official and sole provider for the Feeding America program in Sacramento. Shawn shared that he is working with food bank and mapping how to get donated fruit directly to food closets. He will continue to update the group as new developments arise.

² Mapping Tool Development

During the April meeting, upon adding the Pathways Program as an official engagement criteria in the Neighborhood Roadmap [matrix], Coalition partners requested an enlarged school map to visually inform them about the schools that are connected to the Pathways Program. Partners also noted the need and interest in having additional maps that provided information about other engagement criteria including elected officials for each neighborhood, county vs. city boundaries, food access activities, etc. Rather than creating several separate maps, Shawn and Rangineh will be working with a small group of folks who they hope will help create one interactive, dynamic map that contains all of the aforementioned layers. Given the magnitude of the map in question, the map will likely take a few months to create. Shawn and Rangineh will keep the Coalition updated about what progress is being made.

EVALUATION PRESENTATION

Following announcements, Tiffany Wilson from LPC Consulting presented on the evaluation work done to date. She began by distinguishing that the evaluation LPC is conducting has historically covered Healthy Food for All Grant Grantees, as opposed to the larger Coalition. The evaluation has thus far covered indicators of changes related to the five outcomes identified in the original grant. These five outcomes are also the same outcomes the Coalition is using to guide its work in the collective workplan. By examining indicators, LPC can better determine progress toward the outcomes.

In addition to tracking grantee data, LPC has also tracked specific data at the larger Coalition level including:

- Membership and attendance of Coalition meetings
- **Cumulative Partner Activities**
- Recommendations

Tiffany shared that the Coalition has made significant progress on most recommendations. She also noted that while she is using a shared measurement system for the grant, a shared measurement system does not yet exist for the Coalition. There is an opportunity develop such a system for the Coalition.

Moving into year five of the grant, LPC will be soliciting the following input:

- 1. GIS Maps What activities make sense to geospatially map?
- 2. Activity Categorization How should different activities be categorized (e.g. should all of the classes be classified as one category or should they be differentiated)?
- 3. Assessment based on Collective Impact Framework Given where the Coalition is in its development, it may be time to move the group toward using a Collective Impact framework. The framework is based on a paradigm that would indicate what the Coalition needs to have in place to function highly effectively with the highest impact possible. Tiffany will be sending out the assessment electronically and Coalition members are strongly encouraged to complete and return it by the deadline set forth in the email.

Finally, Tiffany shared that LPC will be focusing a component of the evaluation to help "tell the story" of the work using the lenses of policy, school-based activities, and community-based activities. For questions regarding, please contact Tiffany Wilson at tiffany@lpc-associates.com.
