OCTOBER 18, 2016 | FRUITRIDGE COMMUNITY COLLABORATIVE

OVERVIEW

There is a new mobile vehicle, which the Food Bank will be utilizing at some of the school sites. The conversation has been happening, and this has been implemented in the next grant. This mechanism will be matched more specifically with the more active school sites, if not other Community sites. With this, the hope is to integrate 6 more sites in the mix with the intent of expanding distribution.

UPDATE ON EMERGING ISSUES

The Coalition has been successfully using the new meeting format for a few months. During the August meeting, several community-based issues began to emerge, which have the potential to be discussed beyond the Coalition level. However, Coalition members expressed their interest in further vetting the issues before inviting in additional stakeholders to discuss them. To this end, participants were asked to provide brief updates on the emerging issues. Below is a brief overview of each of the emerging issues as well as the status updates that were shared in October.

Potential Avenues Neighborhood Association	Building a neighborhood association in the Avenues community has hit several bumps over the last few years for a number of reasons. Recently, Chris Puhule (Sacramento County) contacted Sharon Eghigian (NeighborWorks) and Katie Valenzuela Garcia (SUAC/SFPC) about potentially helping to start a neighborhood association.	No update	The group will move forward with the meeting and report back to the Coalition as appropriate.
Healthy Food City Ordinance	The HEAL Zone's Organizing Committee is looking at a Citywide ordinance to minimize over concentration of fast food. The process is still in the research phase and an update should be coming in the next month.	Heal Zone work has shifted due to SB 1000, which was recently signed by the Governor. It is a bill that would add an environmental justice element to the general plan; which includes healthy food access, as well as transportation, healthcare, and housing.	The conversation will continue at the HEAL Zone Organizing Committee and Katie will report back to the Coalition as progress unfolds.
Oak Park Food Collaborative	There are people focused on serving Oak Park who are working on food access issues. Currently, there are more opportunities for collaboration than are being leveraged and as a result, this group is specifically focused on collaborating on food access work in Oak Park.	No update	Set meeting with agencies and groups providing food access, nutrition education, and garden resources to Oak Park residents and bring them to the same table.
Gaps Tour	Karen Abrego (Senator Pan's Office) has been taking folks/students on a tour through the South Sacramento community and elevating gaps in community resources (e.g. medical facilities, grocery stores, etc.).	No update	Karen will report back and share updates with the group as needed.
Increasing Demand for Healthy Food	The focal point of this group's discussion has been answering the following questions: How do we increase demand for farmers market so they don't fail when they come in? How do you take a community that is lacking in [food] access and start at step 1? How do you know the right place to start? What is the assessment process? How do we best organize our work?	No updates	The group needs to flush this out internally and continue to discuss at the Coalition meetings. The interim goal is to continue discussing and eventually bring back to the Coalition for feedback and guidance.

NEIGHBORHOOD SNAPSHOTS

With the implementation of the new meeting format, the Coalition has not had a chance to reflect on how work is unfolding in each of the target neighborhoods. To this end, Coalition members were asked to reflect on the work they are doing in each of the target neighborhoods, and share what activities they are either directly involved with in those areas, as well as share what other activities they know are happening. The activity was meant to serve as a snapshot of the work happening across all the target neighborhoods, uplift opportunities to better collaborate, and note where there may be gaps. While participants were able to fill in their activities, unfortunately there was not time to fully reflect on the data (though a brief conversation did follow). Therefore, the reflection portion was tabled until the November meeting. Below is the data that came out of the activity, including the comments that followed the activity. Please note this activity was not meant to provide a comprehensive overview of ALL the foodaccess related activities happening in these neighborhoods, but rather a snapshot.

Neighborhood Snapshot Comments

- Still have questions about neighborhood boundaries \rightarrow How are community members defining neighborhood boundaries?
- Is there a single-organizing point where the group can be working together?
 - o Oak Park Food Collaborative as an example
 - Want to see more alignment with neighborhood associations and the existing activities (e.g. OPNA will be canvassing don't want to duplicate events, can partner)
 - Other leveraging points are the schools and connecting with parents and sharing info
 - o Layering services and collaborating across neighborhoods has led to greater communication
- If more activation happens, shared vision for neighborhood food systems can evolve
- We're working in neighborhoods but not always letting them direct us, let's sit down together with residents, allow them to direct our work
- We haven't made a point to identify existing gaps and work with them this is where the conversation needs to be like the idea of getting together with the existing groups
- Activation has happened evolution of the work is to get imbedded and for there to be enough buy-in from schools and residents
- Don't have a game plan as a Coalition can show up at neighborhood association groups and offer Coalition services/support with one central point person/representative
- SB 1000 makes it good timing to connect and leverage the synergy thinking about messaging; residents are the audience
- Starting of Sac Urban Ag Coalition outreached to residents initially
- Community Development Action Team's strategy has been to go to neighborhood association meetings
- Most members of HFAC are already attending other meetings just need to present the work
- Disconnect between the people who are being sought to be served and the neighborhood associations; there is a group of people who don't feel enfranchised to go to neighborhood association meetings
- Our work is better, more folks may be willing to work with us and facilitate gaining allies
- Golden Circle → People don't buy what you do but rather why you do it; what are our beliefs?
- Underlying current = Not everyone's work is related directly to neighborhood associations but some audiences also differ; there may be some groups we are working with outside of neighborhood associations worth highlighting
- What if there was a 3rd space? → *Libraries Transforming Communities* curriculum asks: What are your as aspirations as a community? What are the challenges? How can we address the challenges? At the library we're asking how we can listen better
- Needs to be a third group for residents that is just about food-access
- Language being used has to do with how people connect
- We need to listen rather than talk; not about being right/wrong but reaching people emotionally and feeling like its going to be impactful in their lives
- Where are we vs. where we were \rightarrow in theory the residents would begin to take charge with help and support; sometimes you have to sell people on things
- If we went to AGENA and asked them if they want a grocery store, is anyone at the Coalition going to be able to help?
- Lots of misunderstanding about the food-system work

FEEDBACK ON REVISED DRAFT SCHOOL WELLNESS POLICY

The group was asked to provide feedback on the revised draft SCUSD School Wellness Policy, however due to a shortage of time they were not able to review the full policy and provide feedback. To this end, Robyn Krock (Valley Vision) provided the group with an infographic handout capturing key proposed policy changes. Participants was encouraged to send any questions or feedback to Robyn via email after the meeting. Robyn agreed to provide more info at greater length during the following meeting in November.
