



# HEALTHY FOOD FOR ALL COLLABORATIVE JUNE MEETING NOTES

JUNE 20, 2017 | FRUITRIDGE COMMUNITY COLLABORATIVE

# **OVERVIEW**

The Healthy Food for All Collaborative met on Tuesday, June 20, 2017 at the Fruitridge Community Collaborative. A full list of participants can be found at the end of this document. The goals and objectives for the meeting included:

# Report Back Summary:

- Best practices of past engagement efforts  $\rightarrow$  Garden and Food Fair (kids singing garden songs, talking about photo synthesis)
- Kick-off  $\rightarrow$  Looking at getting families more quickly into the garden; need to start working on that "instant action" with parents (e.g. using robo call effectively and creating and plugging into events that are happening right now)
- Another idea to consider would be leveraging open houses that use incentives for kids (e.g. planting trees) have also leveraged Wellness Fairs but there wasn't much interest related to the garden
- Missing best practices with teachers and how to support them
- New Superintendent of SCUSD interested in doing a meet and greet and walk neighborhoods with different groups may be interested in connecting around this
- Parents would be more likely to learn and engage with partners' activities and programs if they are already at events being held
- Next Steps: Talk to Christine re Superintendent and follow up with Laura @ FLC and get outreach dates on calendar

### PART II: FOUNDATION BUILDING

# **Reviewing HFAC's Draft Mission**

Participants reviewed the draft mission statement that reflected their input from the May meeting, and provided additional feedback. To this end, the same two volunteers who drafted the original statement, agreed to take a pass at revising the language and incorporating the following new feedback points:

- Question: For whom? → more specific than "our neighborhoods"
- Do neighborhoods have the vision or just responding?
- Doing = bridging gaps (vs. vision)
- Define: healthy food, food access, and complementary services
- Neighborhoods not all the same, sometimes different scale
- "For all" → Who does this include?
- Like "food system"
- "Food access" → does "food equity" get at the broader context? Different ways to express access

Below are four similar, but slightly different, revised versions of the mission statement that participants will revisit during the July meeting:

# Original:

Healthy Food For All is a partnership of community organizations that work together to improve food-access in Sacramento. Our goal is to amplify our neighborhoods' vision for a healthy and just food system. We do this by sharing resources, ideas, and expertise, partnering on events, and layering complementary services.

### Version 1:

Healthy Food For All is a network of community organizations that work together to achieve food equity in Sacramento. Our goal is to amplify our neighborhoods' vision for a healthy and just food system. We do this by partnering on events and sharing resources, ideas, and expertise.

### Version 2:

Healthy Food For All is a network of community organizations and stakeholders that work together to improve food access in south Sacramento. Our goal is to support the community's vision for a healthy and just food system. We do this by partnering on events and sharing resources, ideas, and expertise.

### Version 3:

Healthy Food For All is a collaboration of community organizations working together to achieve food equity in south Sacramento. Our goal is to support the community's vision for a healthy and just food system. We do this by partnering on events and sharing resources, ideas, and expertise.

### Version 4:

Healthy Food For All is a network of community organizations working together to achieve food equity in Sacramento. Our goal is to support our community's vision for a healthy and just food system. We do this by partnering on events, layering complementary services and sharing resources, ideas, and expertise.

# Prioritizing Foundational Questions to Pave a Path Forward

For the past few months, members of the Collaborative have been addressing several foundational-level questions, with the need for a mission statement being at the top. As the group comes closer to finalizing their mission statement, co-facilitators (Shawn Harrison and Rangineh Azimzadeh Tosang) took a few minutes at the end of the June meeting to discuss how the group would like to move forward with prioritizing the remainder of the questions (see May notes for a list of the questions). To this end, they shared that if it is the intent of the group to focus on planning for post-BHC, that it would be more strategic for the group do engage in a comprehensive planning process (vs. addressing one question per meeting). However, if the intent of the group is not necessarily to plan but rather resolve answering the remaining questions, then addressing the questions one at a time may make more sense. One participant also noted that the group may want to consider if/how it may want to collaborate with the Promise Zone Initiative, which is slated to be in place several years after the BHC Initiative ends. Participants were asked to discuss the question in pairs and the following comments were shared during their report back to the larger group:

- Promise Zone overlap/integration with HFAC meetings?
  - Have vistas who facilitate health/food group
  - Doesn't totally align with existing boundaries but also expands
- Some concern about aligning with Promise Zone funding would be good to spend next 2 years planning for post-BHC (x2)
- In the legacy piece broader Sac food system needs translation of work in order to get to a bigger plan for the future; how our work continues and can be replicated is an important focus
- Not forgetting what we're doing now, need to continue leveraging resources

In conclusion of the discussion, the majority of participants agreed that they would prefer to engage in a more comprehensive planning process for the post-BHC era while remaining mindful of their current commitments and obligations to the existing BHC Initiative. To this end, it will be incumbent upon the co-facilitators to consider how to effectively engage the group in a planning process while balancing time during each meeting to continue focusing on their current work as well as how to strategically continue working together to collaborate and layer services.
